David Browne shared that the Washington County Commissioners asked the Board for a one-time donation of \$10,000 to support the purchase of two therapy dogs for the Sheriff's Department. Mr. Browne also mentioned that he plans to retire in the spring of 2023 and would like Board involvement with the hiring of vacant staff positions that could potentially lead to his replacement.

Tara Plaugher added that she and staff from Oriana House attended the annual Ohio Association of County Behavioral Health Authorities (OACBHA) two-day Opiate and Other Drugs Conference in Columbus on June 6&7.

Laura Silwani thanked Tara for her hard work coordinating the second annual Appreciation Dinner that took place on Thursday, June 16.

X. Agency Reports

- **A.** Hopewell Health- Summer groups for youth have started and are well attended. Hopewell Health is one position away from being fully staffed (knock on wood)! Sherry Shamblin called attention to the Washington County First Responder Mental Health Initiative flyer that was included in the report, inviting attendees to share with others.
- **B. Integrated Behavioral Health-** There were no updates to the report or questions offered.
- C. Life & Purpose Doug Pfeifer shared that the ACT (Assertive Community Treatment) program has increased staffing to ensure they are providing treatment with fidelity. The ACT program is also used in conjunction with the Mental Health Court. David Browne asked those in attendance that provide mental health services if they are noticing a reduction in staff due to the OhioRise program. The OhioRise program is high-intensity coordination for youth. The consensus was yes; the new program is drawing staff from an already strained workforce pool. Attendees held a lengthy discussion on the OhioRise kick-off scheduled for July 1, 2022.
- **D. Rigel/Oriana House-** Coda Kyle reporting on the Rigel outpatient facility on Rt. 7 shared that they have been operating with two staff for the past year, recently expanded to four and clientele is growing. Rigel now offers sublocade in addition to other forms of medication-assisted treatment and plans to offer case management that would include transportation assistance to and from appointments.
- **E.** Memorial Health Systems No report was received.
- **F.** House of Hope There were no updates to the report or questions offered.
- **G.** The Right Path There were no updates to the report or questions offered.
