The Washington County Behavioral Health Board (WCBHB) VISTA, Michele Sturgeon is compiling data from previous service provider utilization reports. The data analysis will help to show a progression of mental health and addiction services offered to Washington County residents. The Opioid Hub will be celebrating the one year anniversary on July 11, 2019 at Gold Star Park.

X. Prevention and Recovery Advocate

Miriam Keith attended the three day Ohio Prevention Conference in Columbus, Ohio from June 24-26. Continuing Education Units (CEU's) will now be available to individuals who complete the Adult and Youth Mental Health First Aid Trainings.

- **C.** Life & Purpose Saturday hours are being offered every other week to help with the demand of services. The Community Resource Center is officially a State 501c3, Federal paperwork will be submitted soon. Doug Pfeifer shared his appreciation for the WCBHB's support.

Stacey Adams asked about the large wait time between a first time appointment request by a client and the available appointment date offered by Life and Purpose. Doug stated many things contribute to the wait time such as small office space, lack of workforce availability in the community, and the large number of intakes. Offering Saturday hours every other week should help reduce the wait time for clients seeking services.

- **D. EVE, Incorporated** Lashley Moser completed education hours need to apply for a prevention specialist certification after attending the Ohio Prevention Conference in Columbus, Ohio. Prevention services are now being offered in the Boys and Girls Club during summer break. In addition to our local mental health and addition providers, Lashley added that Mindfulness Holistic Wellness & Healing is a mental health and addiction service provider in St. Mary's, West Virginia.
- **E.** Oriana House- There are currently eight clients at the third street residential treatment facility. A nurse practitioner is scheduled to join the staff at Rigel Residential Center on July 22, 2019. The Medicaid site visit on May 2 has been

completed. Rigel Recovery Services is short staffed, Christa Holman stated there are not enough qualified applicants in the area to keep up with demands. A staff member from Rigel is available to assist with obtaining recovery services during the "Harm Reduction Clinic" held on Thursdays from 2-4 p.m. at the First Congregational Church located at 314 Front Street in Marietta, OH.

Aleisha Roberson, Program Coordinator for the Washington County "Compass" Drug Court shared that one of the clients completed pretesting for the High School equivalency and was accepted into the program with the Career Center. The client will be graduating with a High School Diploma and certified STNA (State Tested Nursing Assistant) by the end of next month. There are currently fourteen active clients, six have one hundred or more days of sobriety. Staff from Oriana/Rigel attended an NDCI (National Drug Court Institute) week long training in June that focused on best practice standards and intervention in lieu of conviction. Oriana House applied for a Federal grant that would be used to staff certified Peer Recovery Supports that would assist in providing weekend hours for "Compass" Drug Court clients. Until that time, Aleisha has made herself available to clients twenty-four hours a day via work cell phone.

B. Boys and Girls Club Proposal- The Boys and Girls Club proposal was discussed during the Program Planning and Oversight Committee meeting in June. The Washington County Boys and Girls Club (WCBGC) has been approved for a Community Resiliency Reimbursement grant in the amount of \$500,000 provided by the ODMHAS (Ohio Department of Mental Health and Addiction Services). In order to obtain these funds the WCBGC is requesting a revolving fund grant from the WCBHB to assist with initial costs. The grant provided by the WCBHB will be reimbursed within six months after the project's completion, by February 2022.
