Х. **Compliance Director**

Shaeleigh Sprigg shared some disappointing news that the Board will not receive the final two years of HRSA (Health Resources & Services Administration) grant funds. The Community Plan was shared with the County HUB with a deadline of Friday, August 28 to provide any revisions before submitting to OhioMHAS (Ohio Mental Health & Addiction Services). The 11th hour radio show continues to air on Fridays around eleven a.m. on WMOA, the content will also be available on the Washington County Behavioral Health Board (WCBHB) website. The Board has been invited to speak during the "Talk of the Town" segment on Thursday, September 3 at 8:40 a.m. on WMOA to discuss the upcoming Recovery Walk. On a personal note, Shaeleigh shared that she has decided to go back to school to work toward a Master's Degree.

- **A.** House of Hope There were no updates to the report or questions offered.
- B. EVE, Incorporated Eric Fowler shared his interest in viewing the "Too Good for Drugs" prevention videos that Prevention Specialist, Caitlin Simmons has been working on.
- C. Life & Purpose Dr. Pridgeon asked for an update on the Life and Purpose Community Resource Center. Doug Pfeifer shared that although there is no set date to open at this time, in-kind and monetary donations continue to be collected while monitoring the impact COVID will have on the volunteer base to staff the center.
- **D.** The Right Path There were no updates to the report or questions offered.
- E. Rigel/Oriana House- A Compass Drug Court graduate raised roughly eighteen hundred dollars for Brandi's Legacy, a women's treatment center in Marietta, during a community fundraising event. Two Compass clients have given birth to drug free babies. Compass Drug Court continues to meet on Monday's starting at two p.m. The Monday Court hearings are open to the public.
- F. Hopewell Health- David Browne thanked Hopewell Health for their extensive efforts in providing early childhood services to the community. Sherry Shamblin stated that Hopewell Health would be more than interested in providing additional early childhood services in Washington County.

Community Relations** Eric Johnston shared that Rick Marshall, representative for WTAP was in attendance for the August Community Relations Committee virtual meeting to answer questions and provide insight in regards to geofencing offered through the digital media campaign. The committee discussed hosting the first annual Recognition event in late spring of 2021 following a week-long Crisis Intervention Team training hosted by the Washington County Behavioral Health Board. The Recognition event will include a celebration of Crisis Intervention Team Training graduates. Mr. Johnston also mentioned that the committee approved ordering facemasks and t-shirts for a Recovery Walk in September.
- **C. AoD-** Tara Plaugher shared that the committee met prior to the full Board meeting to discuss logistics of hosting a Recovery Walk on September 26 starting at 9 a.m. The walk will begin at the corner of Putnam and Front Street in historic downtown Marietta. All participants will receive a free Recovery Is Beautiful facemask and t-shirt.

Shaeleigh Sprigg shared that Dr. Wittberg is working with Hopewell to use funding through the Rural Community Opioid Response Program (RCORP) to open another harm reduction program in Belpre.

XV. Good of the Order-

A. Appalachian Children Coalition- Zach Space spoke on behalf of the Appalachian Children Coalition made up of State and Regional leaders advocating for the continuum of care for children in Southeast Ohio. The Coalition is currently working toward advancing a policy to expand broadband services in Southeast Ohio that will assist during the pandemic. Mr. Space invited the WCBHB to join in the efforts of the Coalition. To be a contributing member of the Coalition, there is a two hundred fifty dollar monthly fee. Mr. Space shared some insight on the functionality and goals of the stand-alone 501C3. Eric Fowler asked if participation or action is required from members other than the fee. Mr. Space shared that member interaction is welcome/valued but not required however, letters of recommendation to support grants are appreciated. Dr. Raney asked if members of the Coalition get to vote on Board members and if the bylaws could be found on the Ohio Secretary of State's website. Mr. Space was unsure on the answer but ensured Dr. Raney that the Coalition is open to suggestions.
