VII. Treasurer’s Report

David Browne called attention to page one under general funds that show deposits of roughly \$750,000. The State has contacted the Board sharing that a portion of those funds were sent in error, along with other funds received in 2020. Mr. Browne expects a large portion of the primarily withdrawal management funds will be returned to the State upon request.

VIII. Director’s Report- David Browne shared that the Oriana expansion of services will be restricted to the number of beds they will be able to offer until City sewage line updates have been completed. The Oriana expansion located on Rt. 7 in Reno, will start out offering 14-16 detox/residential treatment beds for men and women. Updates to the City sewer lines are expected to be completed within 12-18 months. Once updates are complete, Oriana plan to increase bed availability to 36 at the new location.

Members of the Board held a discussion on the proposed changes to the Ohio Revised Code that would include a more defined psychiatric deterioration standard.

IX. Staff Report- Shaeleigh Sprigg added that the Culture of Quality site visit has been changed to September 21 and 22 of 2021. Members of the Board can look forward to a few more policies to review prior to the site visit. Tara Plaughter added that she and Shaeleigh attended the virtual Opioid Conference on May 11-13.

X. Agency Reports

- A. House of Hope** – There were no updates to the report or questions offered.
- B. EVE, Incorporated** – There were no updates to the report or questions offered.

- C. **Life & Purpose** – There were no updates to the report or questions offered.
- D. **The Right Path** – There were no updates to the report or questions offered.
- E. **Rigel/Oriana House**- Carla Archer shared that the Compass Drug Court hearings will be in-person starting Monday, June 7; the public is invited to attend.
- F. **Hopewell Health**- There were no updates to the report or questions offered.
- G. **PAX**- There were no updates to the report or questions offered.
- H. **Community Health Improvement Associates (CHIA)** – Dr. Wittberg shared that CHIA has secured additional funding to place up to 22 Peers in the surrounding area, 5-6 peers will be placed in Washington County for 2021-2022. CHIA is also working with the Behavioral Health Board staff to create an easy to use data collection system for Peers.
- I. **Integrated Behavioral Health**- There were no updates to the report or questions offered.
- J. **Memorial Health System**- Jovonnah Mayo shared that Memorial Health System is looking for an additional Peer Recovery Supporter to fill the gap in hours.
- K. **Municipal Court**- As a member of the advisory Board for the Mental Health Court, President Fowler shared that they are actively screening for potential clients/defendants that would be good candidates for the program. Life and Purpose Behavioral Health provides the initial assessment in-house using the Ohio Risk Assessment System (ORAS) screening tool that creates a risk of recidivism score.

- A. **Program Planning & Oversight** – Dr. Raney shared that the committee did not meet. Members of the Board held a discussion on the need and future schedule of both the Program Planning and Oversight, and the Community Relations Committee meetings. No action was taken on the discussion.

- C. **AoD**- The committee did not meet. Next meeting is scheduled for June 16 at 6 p.m. via Zoom to further discuss and plan the September 18 Recovery Walk.
