Tim Hahn sat in for Executive Director George Goddard and shared that the Board received a three-year Culture of Quality recertification through the Ohio Association of County Behavioral Health Authorities. He also shared that the Washington County Behavioral Health Board earned an Ohio recovery friendly workplace designation. This recognition reflects the boards commitment to fostering a supportive, inclusive work environment for employees who may be affected by substance use disorders and mental health challenges.

Staff Reports

Assistant Director Tim Hahn had nothing additional to share.

Peer Recovery Advocate Tara Plaugher mentioned Ohio House Bill 57 regarding school policies on administering overdose reversal drugs like Narcan in schools. Tara expressed the importance of knowing what to do in a crisis situation involving a possible overdose.

Peer Recovery Advocate Colt Morningstar shared a social media report regarding polls that were used to ask Washington county residents community questions on Behavioral health. The report showed that the community showed the biggest support in more recovery housing, a crisis stabilization unit for mental health and substance use, and the cost or lack of insurance in our area. These polls can help provide statistics needed for certain state and federal grants if needed in the future.
